

THE SHOPPER'S NEST MEMBER SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. YOU MUST HAVE INTERNET ACCESS AND BE A MEMBER OF THE SHOPPER'S NEST TO ENTER THE SWEEPSTAKES. VOID WHERE PROHIBITED.

1. HOW TO ENTER: Beginning 1/1/18 at 12:00:00 PM (ET) through 12/31/18 at 11:59:59 AM (ET) ("Promotion Period") **Shopper's Nest** members will receive an email invitation with a link included to go to the promotional Website, and then complete the online registration to enter **the Shopper's Nest Sweepstakes** ("Sweepstakes"). The Shopper's Nest Sweepstakes is sponsored by the Shopper's Nest website ("Sponsor"). If you did not receive an email invitation to enter the Sweepstakes, you may still enter by going online to www.theshoppersnest.com ("Website") and then complete the online registration. Registration to enter the Sweepstakes is free. Once registered in the Sweepstakes, **the Shopper's Nest** members will be entered into the Sweepstakes after completion of an activity on the Shoppers' Nest website. There will be *twelve (12)* Sweepstakes Periods (as defined below); each Sweepstakes Period will run for approximately one month during the Promotion Period. The beginning and end dates for each Sweepstakes Period are set forth *BELOW* ("Promotion Window"). A Shopper's Nest member may enter the Sweepstakes multiple times per month with the number of entries varying based on the number of activities offered on Shopper's Nest and the number of completions of each activity(ies) by the Shopper's Nest member. Entries will not be carried over to subsequent Sweepstakes Periods. Administrator will conduct a random drawing each Sweepstakes Period to select fifty (50) winners each month during the Promotion Period. For purpose of this Sweepstakes, a "Month" is defined as a standard calendar month. In the event of a dispute regarding entries, any entry will be deemed to have been submitted by the Authorized Account Holder of the email address submitted at the time of entry, provided that person meets all eligibility requirements set forth in these Official Rules. "Authorized Account Holder" means the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may not participate with multiple e-mail addresses, nor may entrants use any device or artifice to enter multiple times or as multiple entrants during a Month. Any entrant who attempts to enter with multiple e-mail addresses, under multiple identities or uses any other device or artifice to enter multiple times during a Month will be disqualified from participation in the Sweepstakes and all entries submitted by that entrant will be void.

2. ELIGIBILITY: Open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older at the time of entry and who are members of the Shopper's Nest. Employees of Maru/Matchbox LLC ("Administrator"), Sponsor, their respective parent company, subsidiaries, affiliates, advertising and promotion agencies and immediate family members and/or those living in the same household of each are not eligible. Void where

prohibited. Sponsor, Administrator, their affiliated companies, representatives, agents or employees are not responsible for, and shall be indemnified by the prize winner against, any claims, injuries, losses or damages of any kind resulting from acceptance, use, misuse, possession, or loss of the prize.

RANDOM DRAWING: Each Sweepstakes Period, fifty (50) winners will be selected in a random drawing on or about the next business day after the end of the applicable month from among all eligible entries received for the month by Administrator or its designee, whose decisions are final and binding. Winners will be notified by email from Administrator as described in Section 6 below.

4. PRIZES/APPROXIMATE RETAIL VALUES (ARV)/ODDS: Six-hundred (600) Prizes (eleven (50) prizes each month of the Promotion Period) of \$25 each (\$15,000 in the aggregate). Confirmed winners will have the option to redeem their Prize in the form of a pre-paid Virtual VISA card, physical VISA card (\$5 shipping and handling fee is deducted from the balance of the card with this form of redemption), Amazon gift card, PayPal or any other redemption option offered by Administrator’s third party prize fulfillment provider (see Section 6 below for details). Total ARV of all prizes in the Sweepstakes is \$15,000. Odds of winning depend on total number of eligible entries received each Month during the Promotion Period. Unclaimed prizes will not be awarded. All applicable federal, state, and local taxes on prize are the sole responsibility of the prize winner. Limit one (1) prize per person for the Promotion Period. If for any reason the program is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor or Administrator which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Administrator reserves the right at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and to direct the selection of the remaining winners by random drawing from among all eligible non-suspect entries received up to the point of the Administrator's action. Caution: Any attempt by any person to deliberately damage any website or undermine the legitimate operation of the Sweepstakes is a violation of criminal and civil laws and should such an attempt be made, Administrator reserves the right to seek damages from any such person to the fullest extent of the law. Administrator reserves the right at its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the game or web-site or to be acting in violation of the Rules.
